- 3. If one or more provisions of these general terms and conditions are null and void or should be annulled, the other provisions of these general terms and conditions remain fully applicable.
- 4. The prices on this website are the current prices. Subject to misprints and typesetting errors in brochures, folders and (study) guides.
- 5. "Erica Hypnotherapy & Coaching" adheres to the legal requirements and rules of the uk.

Article 3: Registrations

- 1. Cancellation conditions; Full payment for session (s) is required and is non-refundable. Unless cancellations are made at least 24 hours in advance. 2. "Erica Hypnotherapy & Coaching" is first required to provide services and fully implement the session of the client.
- 3. Prices are in Pound / GBP and include the legal VAT unless otherwise indicated.

Article 4: Cancellation,

Article 5: Changes and cancellation by the participant

- 1. It is not possible to change session data by the client unless this has been agreed verbally or in writing. After consultation with "Erica Hypnotherapy & Coaching" (prior to the treatment) it is possible to transfer the appointment to another client.
- 2. Cancellation and change of appointment must take place orally or in writing by letter / e-mail / Whats-app. Cancellations sent on Sunday to "Erica Hypnotherapy & Coaching" will not be accepted until Monday.
- 3. Depending on which "Erica Hypnotherapy & Coaching" receives the written or verbal cancellation, the following cancellation costs will be charged:

Cancellation policy; Full payment for treatment (s) is required and is non-refundable. Unless cancellations are made at least 24 hours in advance.

NOTE:

If canceled within this period, an additional amount of £ 5 will be charged for appointments that take place from 6:00 pm in the evening and on Saturdays.

In case of no-show / No Show for an appointment from 6:00 pm or on Saturday, an additional amount of £10 will be charged. 4. The costs for canceling or rescheduling a session as a result of illness within the cancellation period is always £10. This is allowed a maximum of 2 times, with a third time the full amount for the booked session will be charged.

5. Cancellation as a result of the death of a family member in the 1st degree is only possible by submitting an obituary stating the family connection.

Article 6: Payment

- 1. The amount due for all booked treatments must be paid in full and in cash immediately after session. Business invoice payments are also possible in consultation and must be credited to the account of "Erica Hypnotherapy & Coaching" within the stated payment term on the invoice. the invoice number, unless otherwise agreed or stated.
- 2. If payment has not been made in the agreed manner, the client is in default by operation of law. The client then owes the statutory interest. All costs caused by the client's default, such as loss of interest, collection costs, judicial and extrajudicial costs, will be borne by the client, with a minimum of £40.
- 3. If timely payment has not been made, the client may be refused access to the treatment, unless it has been explicitly agreed in writing to pay the amount due in advance by bank or cash.
